Some instances of plagiarism, self-plagiarism, and even some writing practices that might otherwise be acceptable can constitute copyright infringement. Researchers are strongly encouraged to become familiar with basic elements of copyright law. Researchers should strictly adhere to the spirit of ethical writing and avoid reusing their own previously published text. Authors should strive to obtain the actual published paper. When the published paper cannot be obtained, cite the specific version of the material being used, whether it is conference presentation, abstract, or an unpublished manuscript. Always consult the primary literature. The references used should only be those that are directly related to its contents.

#### Guidelines

- 1. Cited references, quotes or data are not treated as copying.
- 2. Always acknowledge the contributions of others and the source of their ideas.
- 3. Any exact text taken from another author must be enclosed in quotation marks.
- 4. Always acknowledge every source even when we are paraphrasing or condensing a material.
- 5. When in doubt about a concept or fact, always provide a citation.

- 6. Double-check of the citations is strongly recommended. Always run your material through the anti-plagiarism software meant to check duplication of your content.
- 7. The researcher shall also submit a declaration to be recorded on the plagiarism report obtained from the software.
- 8. If an author must rely on a secondary source to describe the contents of a primary source, s/he should consult writing manuals used in his or her discipline to follow the proper convention to do so. Always indicate the actual source of the information being reported.
- 9. When borrowing heavily from a source, authors should always craft their writing in a way that makes clear to readers, which ideas are their own and which are derived from the source being consulted.
- 10. Only those individuals who have made substantiated contributions to a project merit authorship
  - and a mention. Faculty/Student must exercise great care to neither award authorship to them whose contributions do not merit it, nor to deny authorship and due credit to the work of students.
- 11. Ghost authorship in any form in any field is ethically unacceptable.

- 2. Annexure (i), (ii), (iii) and (iv) as regard to must be submitted along with thesis :

  - (iii) Self exclusion certificate from supervisor.
  - (iv) Self co-authors /investigator certificate (where ever necessary)
- 3. Thesis/ dissertations that are found to be having more than 30% of content from another individual's material would be treated as Plagiarised.
